Definition Guidance for waterbird count

The primary Focus of the counts is to identify waterbird number including many non-game species. "providing invaluable information on the ecosystem health of wetlands and rivers"

Information the count requires is

- Wetland Name name of the wetland being monitored
- **DELWP Region** there are six regions FGA is simply aligning with them GV Hume, Gippsland, Metro (Port Phillip), Grampians, Loddon Mallee and Barwon SW.
- Percentage of Wetland Counted The estimated are of the wetland counted.
- Percentage of Water Covering Wetland The amount of water covering the bed of the Wetland.

- Waterbird Numbers the number of waterbirds seen for each of the species.
- Clutches and Young if any breeding was observed
